



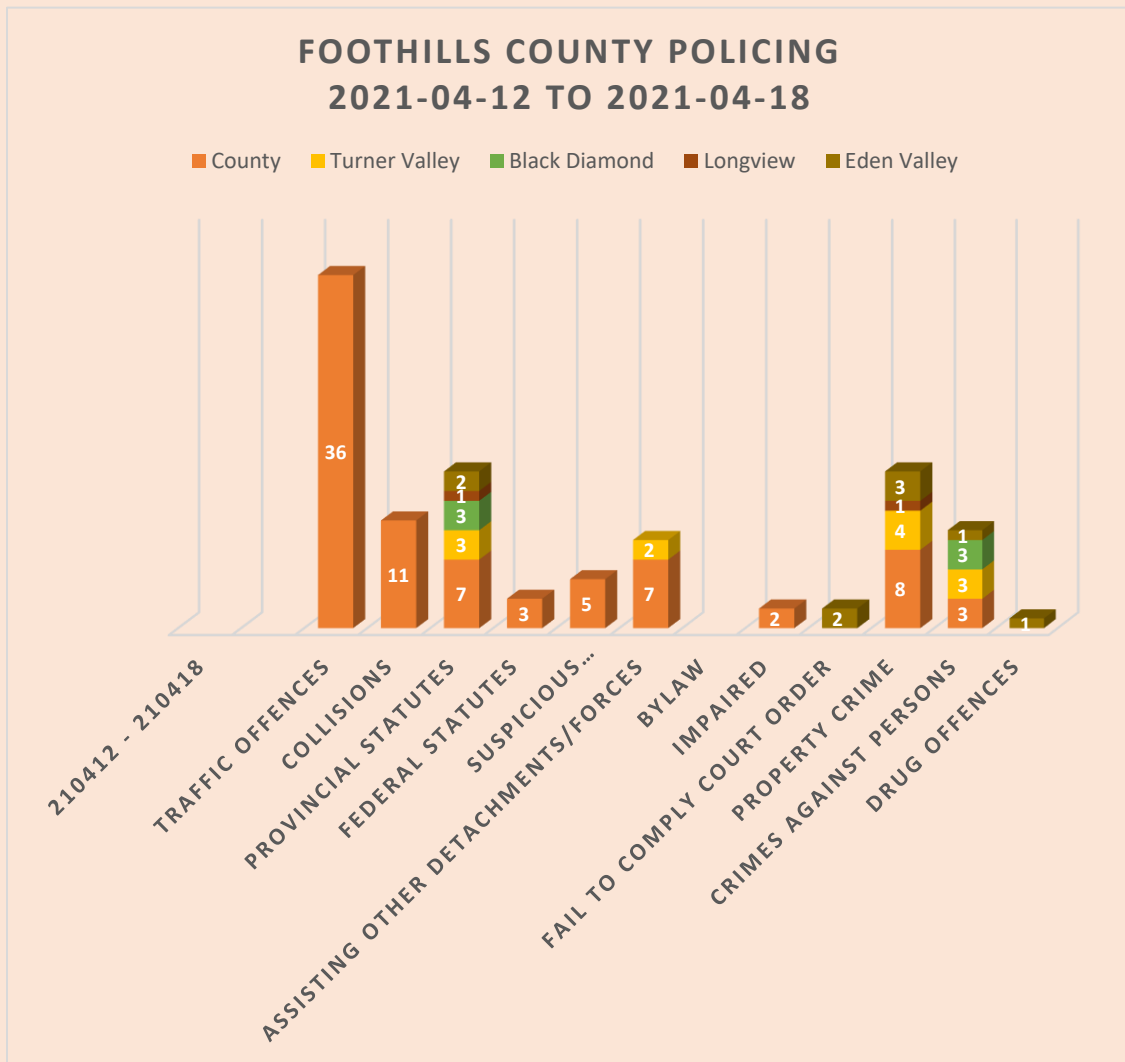

#### **WHAT WENT ON LAST WEEK?**

On April 13, 2021 at approximately 7:00pm Foothills County RCMP responded to a suspicious vehicle parked at the Aldersyde Petro-Can. The occupant of a white Ford Transit Connect van was observed to be committing an indecent act inside the vehicle. This vehicle has been observed in the parking lot on two other occasions. The vehicle left the location prior to police arrival, and this matter is still under investigation. If anyone has information regarding this or similar incidents, please contact the Foothills County RCMP.

On April 14, 2021, Foothills County RCMP attended a complaint of a male in the Black Diamond Dog Park threatening to Bear Spray Dogs. The suspect is described as being in his mid 60's and was wearing a bulky black winter jacket and touque and was reported to be carrying a sink.
